
# Mancy Intini, Operation Manager



### Tax Collector Mike Fasano Announces an Exciting New Service for Customers!

"It is my pleasure to announce that our staff and the state have been working together to make a vehicle registration renewal kiosk available to our customers," Tax Collector Mike Fasano announces as Pasco's first-ever self-serve kiosk for processing vehicle registration renewals becomes operational. "We understand that many times the only transaction a customer may have is the annual renewal of their vehicle registration. The kiosk will allow them to dash into the grocery store either during a regular shopping trip or just while out running errands, thus saving the time of driving, and waiting at one of our offices. It is exciting that this new service may save our customers time, gasoline and potentially the inconvenience of travelling far to one of our full-service locations."

The kiosk is in the Publix Supermarket at Collier Commons, 2121 Collier Parkway, Land O'Lakes FL 34639. We have placed the kiosk inside the Publix Supermarket at the entrance near the customer service counter and the pharmacy to make the transaction safe and secure. The kiosk is available to the public during store hours.

Vehicle registration renewals are the only transaction the kiosk is currently designed to complete, saving customers a visit to their local tax collector's office. If you are interested in renewing your vehicle's registration at the kiosk you must bring the following information with you:

- PIN from registration renewal notice or license plate number and first Registrant's date of birth.
- Registrations in a business name can only be renewed with the PIN since there is not a date of birth linked to the record.

IMPORTANT: The following registrations are NOT eligible to be renewed at the kiosk:

- Registration renewals that require an address change.
- Registration renewals that replace a license plate.
- Registration renewals that have insurance, driver license, or toll suspensions.
- Vessel(boat)registration renewals.
- Mobile home registration renewals.
- Heavy trucks that require a Florida Certificate of Insurance or IRS Heavy Vehicle Use Tax "2290".
- Personalized plate reservations.
- Parking permit or placard renewals.
- National Guard license plate renewals.
- Autonomous vehicles

- Government vehicles
- IRP Registrations

Accepted form of payment: American Express, Discover, Mastercard, & Visa.

\*\*Debit/Credit Card ONLY\*\*

The new registration and decal will be printed at the kiosk once the customer has entered their information. If there is a driver license stop, toll stop, or insurance stop, the customer will receive a message from the kiosk. If the kiosk is unable to process the transaction and the registration is not able to be issued, the kiosk will notify the customer.

The kiosk charges a 2.3% fee for use of a credit card AND a \$3.95 flat fee for renewing at the kiosk. Customers can still make a voluntary donation to one of the many authorized charities just as they are listed on the back of the renewal notice. The kiosk does ask the customer to verify the vehicle and plate they are renewing as well as the fees before the transaction is completed. It also asks the customer if there are any address changes, if they answer yes, the transaction cannot be completed. If they answer no, it continues. If the registration qualifies, the kiosk does offer a 1-year or 2-year renewal to the customer. If a customer has a question or problem, they may contact the Kiosk Customer Care Number which 1-833-939-1572.

### Note from BOARD SUPERVISOR by Norm Keith



I wrote this article 9 years ago. As I read it again it occurred to me that might interesting for our residents to reflect how things appeared to be taking shape in Oakstead 9 years

#### Things are changing in Oakstead!

As I walked my little dog around the neighborhood, on a cool crisp evening in 2003, I saw houses being built along Judson and around Briley Loop. Strathmore was just about finished and Marchmont was being developed. Brenford had model homes and Ballastone was just being started. The stars were bright, and everything seemed really quiet and peaceful.

As I walked my little dog around the block on a cool crisp evening in February 2015 the stars were bright, I could see the Little and Big Dippers and several Airliners with headlights on as they approached Tampa International Airport. I could hear a pack of coyotes yelping, owls hooting, and cats scurrying all over the place. Things were not quite as peaceful as in 2003.

In 2015 all Oakstead Villages have been completed and many of the homes have been repainted. It appears that our beautiful community has settled in and established its identity. Home values are rising, foreclosure numbers, so numerous for several years, are way down and resales are brisk. Maintaining our homes is extremely important because with all the construction beginning between Oakstead and the Sun Coast Parkway thousands of new homes will soon be on the market.

Huge changes are quickly approaching. The Pasco County Planning Commission has approved new development along SR. 54 northward to County Line Road and on to SR50. Development of Lake Patience Road and Sunlake Boulevard will soon have a major impact on the traffic flow through Oakstead. I have a feeling that Oakstead Boulevard will become a major connector between SR41 and SR54. The development of the SR41 and SR54 intersection might alleviate some of the problems but it may be several years before that project is completed. All of this coupled with school zones etc. might make traffic lights at some Oakstead intersections necessary.

As many of us know, Oakstead was developed as a natural setting with wildlife corridors winding by large ponds. As

development closes in all around us I have real concerns that this setting will be lost, and wildlife populations will be decimated until even the Sandhill Cranes will be gone. What a shame this would be.

Residents have spoken out and fought several development battles in the past. The Progress Energy Power Pole Project was defeated, uncontrolled development of the land parcel by the Oakstead entryway was postponed and the elevated highway for SR54 project was stopped. Who knows how long it will be before Pasco County loses its rural identity?

One of the major concepts that Pasco County Planners are initiating is the idea of self-contained communities which allow residents to work, shop, receive medical care and educate their children without leaving the community. This will have a major impact on traffic flow within Pasco County.

In closing residents should reflect on this article that was written 9 years ago and the fact that these predictions have become reality.

I sincerely hope this concept works so that Oakstead remains a truly nice place to live where we can continue to say, "Welcome home", at the end of each day.
