# Veymouth NEWS by Steve Shaw

The Weymouth HOA is excited to introduce the two newest members appointed to our HOA Board of Directors. Ryan Fisher and Marilyn Shafer joined the Board on July 26<sup>th</sup>, and their two-year terms will run through July 2025. Both will serve as Directors at Large until our Annual Meeting on September 27<sup>th</sup> at 7pm at the clubhouse so be sure to note this important meeting in your calendars. Members of the Board and members of our committees will provide PowerPoint presentations that will include a detailed year-to-date Treasurer's report, information about the on-line ARC request procedures, landscaping, villa painting, and more.

The Board approved and ordered a reserve study that is scheduled to be completed by mid-October and 2024 assessments will be calculated as a result. Weymouth residents can expect payment coupons to be printed in November and mailed out to homeowners in December.

There is plenty of anticipation about the upcoming painting of the villas. The paint committee, led by Marilyn Shafer, is collaborating with Sherwin Williams representatives to select a new paint palette, develop a scope of work, and hire a company to paint the exterior of our homes. While we cannot guarantee that your home will be painted in your favorite color, there is discussion about the entire community having an opportunity to participate in selecting the new palette.

You will want to be subscribed to receive email notifications from Greenacre to learn how you can participate.

Landscaping remains a hot topic in Weymouth with some residents voicing that the community has never looked better while others are dissatisfied with our current vendor. It was suggested that we put the current landscape contract up for bid instead of automatic renewing our existing contract. The landscape committee will be charged with the responsibility of developing a request for proposal, evaluating potential vendors, and selecting the winning vendor that will provide future landscaping services.

Good news and bad news about the recent vote to eliminate the weight restriction on dogs. The change was approved by the community in a 103 -7 vote. The good news is that 120 members of the community took the time to vote on this initiative. The bad news is that 112 homeowners did not have their voices heard. Our documents are over 20 years old and need refreshing. This is a major undertaking, but it is not impossible. The Oakstead HOA is working to update their documents. Our documents can be more restrictive than Oakstead's, but they cannot be more lenient. We will wait until Oakstead completes their updates before we begin working on ours. If you are interested in helping with this initiative, please contact the Board.



If the wound does not look good, take no chance and go to the emergency room immediately for treatment.

## **History of Labor Day**

## Labor Day: What it Means

Labor Day, the first Monday in September, is a creation of the labor movement and is dedicated to the social and economic achievements of American workers. It constitutes a yearly national tribute to the contributions workers have made to the strength, prosperity, and well-being of our country.

## **Labor Day Legislation**

Through the years the nation gave increasing emphasis to Labor Day. The first governmental recognition came through municipal ordinances passed during 1885 and 1886. From these, a movement developed to secure state legislation. The first state bill was introduced into the New York legislature, but the first to become law was passed by Oregon on February 21, 1887. During the year four more states — Colorado, Massachusetts, New Jersey, and New York — created the Labor Day holiday by legislative enactment. By the end of the decade Connecticut, Nebraska, and Pennsylvania had followed suit. By 1894, 23 other states had adopted the holiday in honor of workers, and on June 28 of that year, Congress passed an act making the first Monday in September of each year a legal holiday in the District of Columbia and the territories.

## Founder of Labor Day

More than 100 years after the first Labor Day observance, there is still some doubt as to who first proposed the holiday for workers.

Some records show that Peter J. McGuire, general secretary of the Brotherhood of Carpenters and Joiners and a cofounder of the American Federation of Labor, was first in suggesting a day to honor those "who from rude nature have delved and carved all the grandeur we behold."

But Peter McGuire's place in Labor Day history has not gone unchallenged. Many believe that Matthew Maguire, a machinist, not Peter McGuire, founded the holiday. Recent research seems to support the contention that Matthew Maguire, later the secretary of Local 344 of

the International Association of Machinists in Paterson, N.J., proposed the holiday in 1882 while serving as secretary of the Central Labor Union in New York. What is clear is that the Central Labor Union adopted a Labor Day proposal and appointed a committee to plan a demonstration and picnic.

### The First Labor Day

The first Labor Day holiday was celebrated on Tuesday, September 5, 1882, in New York City, in accordance with the plans of the Central Labor Union. The Central Labor Union held its second Labor Day holiday just a year later, on September 5, 1883.

In 1884 the first Monday in September was selected as the holiday, as originally proposed, and the Central Labor Union urged similar organizations in other cities to follow the example of New York and celebrate a "workingmen's holiday" on that date. The idea spread with the growth of labor organizations, and in 1885 Labor Day was celebrated in many industrial centers of the country.

## A Nationwide Holiday

The form that the observance and celebration of Labor Day should take was outlined in the first proposal of the holiday — a street parade to exhibit to the public "the strength and esprit de corps of the trade and labor organizations" of the community, followed by a festival for the recreation and amusement of the workers and their families. This became the pattern for the celebrations of Labor Day. Speeches by prominent men and women were introduced later, as more emphasis was placed upon the economic and civic significance of the holiday. Still later, by a resolution of the American Federation of Labor convention of 1909, the Sunday preceding Labor Day was adopted as Labor Sunday and dedicated to the spiritual and educational aspects of the labor movement.

The character of the Labor Day celebration has undergone a change in recent years, especially in large industrial centers where mass displays and huge parades have proved a problem. This change, however, is more a shift in emphasis and medium of expression. Labor Day addresses by leading union officials, industrialists, educators, clerics and government officials are given wide coverage in newspapers, radio, and television.


The vital force of labor added materially to the highest standard of living and the greatest production the world has ever known and has brought us closer to the realization of our traditional ideals of economic and political democracy. It is appropriate, therefore, that the nation pay tribute on Labor Day to the creator of so much of the nation's strength, freedom, and leadership — the American worker.



## FOOTBALL CAKE POPS

## **Ingredients**

- 1 chocolate cake mix (regular size)
- 1 cup cream cheese frosting
- 1 cup dark chocolate chips
- 1 cup peanut butter chips
- 1 tablespoon shortening
- 48 4-inch lollipop sticks
- 1/4 cup white decorating icing



## **Directions**

⇒ Bake cake according to package directions; cool completely. In a large bowl, break cake into fine crumbles. Add frosting and stir until fully incorporated, adding more frosting if needed, until mixture maintains its shape when squeezed together with palm of hand. Shape 1 tablespoon into a ball,

then mold into the shape of a football. Repeat with remaining mixture. Place on parchment-lined baking sheets; refrigerate until firm, about 30 minutes.

- Meanwhile, place chocolate chips, peanut butter chips and shortening in a microwave-safe bowl. Microwave 30 seconds and stir; repeat, stirring every 30 seconds until melted and smooth, adding more shortening if needed. Do not overheat.
- Dip a lollipop stick into chocolate mixture; insert halfway through a football shape, taking care not to break through the other side. Return to baking sheet until set; repeat to form remaining cake pops. Coat each cake pop with the chocolate mixture, allowing excess to drip off; reheat and stir chocolate mixture as needed. Return cake pops to baking sheets, ensuring they do not touch one another. Allow chocolate coating to set until firm to the touch. To decorate, use icing to draw laces onto cake pops.
